AS SUCH, THE MOST SIGNIFICANT PROGRAM OF THE FOUNDATION IS THE DISTRIBUTION OF FUNDS FOR PROGRAMS THAT SUPPORT ESKENAZI HEALTH'S PHILOSOPHY OF EXCEPTIONAL CARE FOR ALL. SUCH PROGRAMS INCLUDE THE PALLIATIVE CARE PROGRAM, SENIOR CARE PROGRAM, AND PRESCRIPTION FOR HOPE (A PROGRAM AIMED AT REDUCING THE THREAT OF REPEATED VIOLENT PERSONAL INJURY AND HELPING FAMILIES WHO HAVE EXPERIENCED VIOLENCE RELATED INJURY MAKE LIFE CHANGING AND LIFE SAVING CHOICES). ADDITIONALLY, THE FOUNDATION HAD A CAPITAL CAMPAIGN TO HELP RAISE CONTRIBUTIONS FOR THE NEW SIDNEY AND LOIS ESKENAZI HOSPITAL THAT CONCLUDED IN 2014.
